Important Notice to Special Class 5c Permit Holders:

The Canadian Dairy Commission has decided to adjust the component pricing established for the Special Milk Class 5(c). The reason for this change is to encourage the use of solid non-fat dairy products such as skim milk powder in the domestic market and to align the pricing in Special Class 5(c) with 5(a) and 5(b) pricing.

Effective July 1st 2003, the component price established for "other solids" in Special Class 5(c) will be lowered from \$2.60/kg to \$2.00/kg and the "butterfat" component price will be adjusted from \$1.90/kg to \$3.374/kg. The net result is expected to be revenue neutral for milk producers.

This advance notice should allow businesses to make adjustments, if necessary, with their suppliers. The CDC hopes that the adjustment to Special Class 5(c) pricing will cause minimal disruption to permit holders.
