Attention Dairy Product Manufacturers and Further Processors!

Are you looking for ways to grow your business? Do you need help in product innovation, but lack the resources? If so, we have good news for you.

The CDC has created two new funds to facilitate access to expert technical support and advice:

1. **Direct Access Fund** - Initial limited free access of up to 7.5 hours will be offered to processors and further processors to encourage consultation with food science centres and recognized experts.
2. **Innovation Support Fund (ISF)** - An expansion of the Milk Ingredients Technical Support Program (MITSP) that incorporates the notion of technology transfer and innovation in support of dairy product manufacturers and food processors. Funding will be provided for some of the initial costs for advice in investigating the feasibility of new projects and for certain marketing and technical costs throughout the development process. Projects which qualify under the ISF will receive up to \$25,000 of funding assistance.

Note: These funds will be available as of January 2005.
