#### Special Milk Class Permits 5 (a), (b) and (c) Attention: Dairy Product Manufacturers, Distributors and Further Processors

Please take note that current Special Milk Class Permits issued under 5 (a), (b) and (c) are set to expire on July 31<sup>st</sup> 2006.

The Canadian Dairy Commission (CDC) is now in the process of issuing new Special Class Permits to Further Processors and Distributors. The new Permits are being issued in advance of the August 1<sup>st</sup> effective date to allow Distributors and Further Processors sufficient time to notify their manufacturers/ suppliers of their new Permit number(s).

Distributors and Further Processors will receive their new Permit(s) by June 30<sup>th</sup> 2006 latest. The new Permits can only be used for purchases and sales transactions which take place on/after August 1<sup>st</sup> 2006.
