CDC Matching Investment Fund Renewed

The Canadian Dairy Commission (CDC) announced the renewal of the CDC Matching Investment Fund (MIF). The MIF provides non-repayable contributions to Canadian registered companies or food technology centres for consultation and product development on a matching investment basis.

The revised MIF will be launched August 1, 2012. The CDC will dedicate \$500,000 over two years for consultation and/or product development projects. New program features include:

- up to \$150,000 per project in funding;
- added flexibility and expanded eligibility criteria;
- simplified application process; and
- special provisions for small businesses.

With this new version of MIF, the CDC expects the program will be more accessible and the application process will be easier for applicants. This announcement reconfirms the CDC's commitment to promoting growth and innovation in the manufacture and use of dairy products and components
