CDC Matching Investment Fund Renewed

The Canadian Dairy Commission (CDC) announced the renewal of the CDC Matching Investment Fund (MIF). The MIF provides non-repayable contributions to Canadian registered companies or food technology centres for consultation and product development on a matching investment basis.

The revised MIF will be launched **August 1, 2012**. The CDC will dedicate \$500,000 over two years for consultation and/or product development projects. New program features include:

- up to \$150,000 per project in funding;
- added flexibility and expanded eligibility criteria;
- simplified application process; and
- special provisions for small businesses.
