## **NOTICE TO** SPECIAL MILK CLASS PERMIT HOLDERS

#### MORE DETAILS ON THE NEW SPECIAL CLASS REPORTING SYSTEM

The Canadian Dairy Commission (CDC) has developed a new web-based reporting system that will simplify the reporting of purchases and sales by further processors and distributors registered in the Special Milk Class Permit Program (SMCPP). This system is called the Milk Ingredient Reporting System or MIRS.

SMCPP permit holders will be given access to the webbased reporting system 24 hours/day, 7 days/week to input information required under the SMCPP and to apply for new finished products.

The portal will ensure the confidentiality of data through measures such as the Government of Canada's GCKeys authentication process and industry-recognized encryption methods.

Permit holders will need to decide who, in their company, will have the right to enter their Special Milk Class reports in MIRS. To log into the portal, this person (there can be more than one) will have two options: create her own CGKey or log in using information related to a Log-in Partner such as a bank. More information on the GCKey log-ins will be communicated in a few weeks.

MIRS will allow the CDC to reduce the time needed to reconcile Special Class data. We hope to complete all reconciliations within 90 days of the end of the company's fiscal year.

Further details on MIRS will follow in the coming weeks.
